## Council Decisions - December 10, 2019

- 1. That Council repealed the resolution dated October 15, 2019 which directed staff to submit an application for funding to expand TPR.
- 2. Council approved the following amendments to the Finance Committee:
  - a. drawing down \$2,178 from the Organization Restructuring and Efficiency Funding for staff expenses incurred related to the Strategic Organizational Review
  - b. drawing down \$28,250 + HST from the Organizational Restructuring and Efficiency Funding for consulting services related to the recruiting and hiring of a Chief Administrative Officer.
  - c. any net revenues from the Centennial Committee project at the end of 2019, and all revenues generated from the Gold Coin Project, be transferred the 'Centennial Committee Reserve' until a future use is determined by Council.
  - d. drawing down \$763.54 from the Organizational Restructuring and Efficiency Funding for the over-budgeted expenses related to the Mechanic Diagnostic Computer.
- 3. Council requests the Timiskaming Health Unit Reserves be returned to the participating funding municipalities under the same formula as collected and the money be placed in a RESERVE FUND until final decisions are made and carried out by the Province of Ontario the intent of which is to fund future Timiskaming Health Unit operating costs.
- 4. Council approved the implementation of Use of Hydrant Permit Application.
- 5. Council approved attendance of the following members of Council and Staff at the following conferences: Association of Municipalities of Ontario, Federation of Northern Ontario Municipalities, Northeastern Ontario Public Works Organization; Temiskaming Municipal Association, and Temiskaming Mayor's Action Group.
- 6. Council approved hosting a Material Household Hazardous Waste Drop-Off event on May 23, 2020.
- 7. Council directed the Interim Chief Administrative Officer to proceed with application to the Investing in Canada Infrastructure Program: Green Stream for energy retrofits to the Water Treatment Plant.
- 8. Council passed a bylaw to execute all documents related to the easement over 155 Archer Drive.
- 9. Council passed a bylaw to authorize Mayor and Clerk to execute a Data Sharing Agreement with the Ministry of Transportation.
- 10. Council passed a bylaw to increase water rates 2% beginning in January 2020.
- 11. Council passed a bylaw to amend Bylaw 18-147 extending User Fee Rates to June 30, 2020.
- 12. Council passed a bylaw to assign Members of Council to Council Staff Committees.
- 13. The bylaw presented to Amend Bylaw 12-019 Regulating Zoning re: Nettie Lake was defeated.
