



COUNCIL DECISIONS – MAY 18, 2021

1. Council received the proposed 2021 Capital and Operating budgets and recommended minor changes to be implemented to present back at the June 1 Regular Meeting of Council. Staff and Council are aiming to have the budget passed at the June 15 Regular Meeting of Council
2. Council resolved to have staff be directed to shop around and report back with options and prices for consideration of purchasing an aerial fire truck
3. Council resolved to have staff be directed to apply to the Green and Inclusive Community Buildings Fund for Community Complex retrofits and to apply to the Canada Healthy Communities Initiative for enhancing trails in rural areas
4. Council received an update on the status of the Community Safety and Well Being Plan
5. Council approved updates to the Accessible Customer Service policy and the Accessible Employment policy
6. Council resolved to have staff be directed to procure the services of a consultant to complete a Pay Equity, Compensation and Job Evaluation Review for the entire Corporation including unionized and non-unionized staff
7. Council resolved to have staff be directed to update the Corporate Zoom account to allow utilization of the Zoom Audio Transcripts to ensure posted videos to YouTube meet accessibility requirements
8. Council resolved to have staff be directed to finalize an agreement with Horizon Drive In to utilize the Water Street Parking lot on July 30, 2021 for a rental price of \$325 +HST for a Drive In Movie event and for staff to include a parking lot rental rate in the user fee by-law
9. Council received information on changes to the composition of the Police Service Board
10. Council passed a by-law to permit the operation of certain off-road vehicles within the jurisdiction of Kirkland Lake

11. Council passed a by-law to authorize the execution of an inter-municipal agreement with municipal area partners with respect to the Provincial Offences Act
12. Council passed a by-law to repeal by-laws associated to a lease agreement at 69 Federal Street and an encroachment agreement at 152 Taylor Avenue
13. Council passed a by-law to authorize the signing and execute the collective agreement with ONA
14. Council denied a tree removal request at 111 Tower Street
15. Council resolved to have staff be directed to submit a letter of support to the KL Opioid Task Force for their proposal of converting Pinegar into an Addiction Residential Community
16. Council received a letter from the Chamber of Commerce asking for explanation of what is being done with derelict building in town and resolved to have staff be directed to submit a letter explaining what measures are in place and available to residents to assist with this problem
17. Council received correspondence from DTSSAB and the Town of Englehart
18. Council received a notice on the measures of protection to Gull Lake while reconstruction on highway 66 occurs
19. Council rose from Closed Session and noted the CAO hiring committee members have been amended to remove Councillor Rick Owen and replace with Councillor Casey Owens
