

Council Decisions- February 7, 2023

- Council received a delegation from the Municipal Property Assessment Corporation (MPAC).
- Council received a delegation from the Ontario Clean Water Agency (OCWA).
- Council received a verbal report from the Chief Administrative Officer on the Town's representation at the Rural Ontario Municipal Association (ROMA) Annual Conference including a summary of the delegations made before various Ministers.
- Council approved (by by-law) the 2023 Water and Wastewater Rates.
- Council approved the 2023 Budget Schedule. The upcoming meeting dates are published on the <u>Town's website</u>. A public survey will be published on the Town's social media streams early next week. Once the budget has been tabled, public participation will be welcomed on March 29 beginning at 4:40 PM; please contact the Clerk to confirm your attendance and to ensure accessibility arrangements can be achieved.
- Council approved a Contract Extension Agreement with RMS Building Consultants for Building Services and appointed (by by-law) a Chief Building Official and Building Inspectors on an interim basis.
- Council received the Town's 2022 Annual Accessibility Report. Public comments are welcomed and encouraged. Please do so on our social media streams and/or by completing the attached form.
- Council approved a Council Conference Attendance Policy and this year's participation
 of Administration and members of Council at conferences hosted by the Rural Ontario
 Municipal Association (ROMA), the Ontario Good Roads Association (OGRA), the
 Federation of Northern Ontario Municipalities (FONOM) and the Association of
 Municipalities of Ontario (AMO) on behalf of the Town.
- Mayor Wight brought Notice of Motion to be considered at the February 21, 2023 meeting seeking the support of Bill 42 Gender Affirming Healthcare Act.
- Mayor Wight brought Notice of Motion to be considered at the February 21, 2023 meeting seeking the support of a request for Phlebotomy Services in the North End of the District of Timiskaming.
- Council approved the appointment of the Town's Chief Administrative Officer, Mayor and Councillor Dikens as Board of Directors on the Kirkland Lake Tourism Development Corporation Board of Directors.
- Council declared 69 & 73 Brant Street as Surplus Land and approved the sale of land for the south parts of 69 and 73 Brant Street to Ted & Kim Comba.
