Position Title: Business Office Co-ordinator

Department: Teck Pioneer Residence

The Business Office Co-ordinator oversees daily operations of the business office and supports the Executive Director and supervisory staff through administrative and financial duties. The Co-ordinator ensures that office procedures are well-organized, records are kept up to date, and visitors, residents, and families receive a warm and professional welcome.

A major part of this role involves managing the Home's financial responsibilities. This includes resident billing, vendor reconciliations, and specialty billing for government agencies. The manager also maintains resident trust accounts and prepares annual statements, ensuring all financial matters are accurate, transparent and properly documented.

Supporting residents is a key component of this position, assisting with tax submissions and other government forms, appointments, correspondence, managing the admission process, and arranging tours. The Co-ordinator also contributes to daily operations across the Home helping with recruiting, payroll review, Health and Safety inspections, and also takes on additional tasks as assigned by the Executive Director and Director of Long-Term Care & Senior Services.

Peak Winter Heating Fire Safety Tips: Stay Safe and Warm

As temperatures plummet across Ontario, heating-related calls and community questions start to rise - along with preventable incidents.

Know the Risks: Causes of Heating Fires

Some of the most common culprits of winter heating fires include:

- · Fireplaces and fireplace inserts
- Woodstoves
- Chimneys
- Furnace

These systems, when improperly installed, maintained, or operated, can easily become fire hazards. As you engage with your communities, keep emphasizing the practical behaviours that reduce those risks.

Professional Installation & Maintenance

- Have woodstoves, fireplaces, chimneys, and furnace installed by a qualified technician following the manufacturer's specifications.
- Schedule annual inspections and cleanings of your heating system, chimneys, and vents by a certified service technician. Find a registered contractor at TSSA.org
- Ensure outside heating vents are not blocked; blocked vents can lead to dangerous carbon monoxide build-up. Make sure they're clear of snow, debris, and ice.

Always Practice Safe Usage

- Use a fire screen: Always place a sturdy fire screen around fireplaces to prevent sparks or embers from escaping.
- Handle ashes responsibly: Let ashes from woodstoves or fireplaces cool completely before disposing of them in a metal container with a tight-fitting lid, kept outside and away from your home.
- Don't overload your stove or fireplace: Overfiring can damage your chimney and increase fire risk

Stay Alert with Smoke & CO Alarms

- Install smoke and carbon monoxide alarms on every storey of your home, especially near sleeping areas.
- Test all alarms monthly and replace batteries at least once a year.
- Know the sounds: Learn the difference between the smoke alarm and carbon monoxide alarm signals. React promptly to

Enjoy the heat, not the risk. A little fire-safe preparation keeps your winter warmth from becoming a winter emergency.
