#### **MUNICIPAL SPOTLIGHT**

Position Title: Director of Community Services

**Department:** Community Services

Reporting to the Chief Administrative Officer (CAO), the Director of Community Services provides strategic leadership and oversight for five key divisions: Parks, Facilities, Recreation, Cemetery Services, and Culture.

The role oversees operating and capital budgets, manages financial forecasting, and monitors performance to ensure fiscal responsibility and operational excellence. By supporting Division Heads, the Director fosters high standards of service, safety, and accountability throughout the department.

The Director works closely with local organizations, advisory committees, volunteers, user groups, and funding agencies to strengthen partnerships and enhance community engagement. 
## Why water use restrictions are important

Summer water use restrictions help ensure a reliable water supply, environmental sustainability, and responsible infrastructure management by complying with outdoor watering schedule.

#### Reliable water supply

Each year, the warmer weather is associated with a higher demand on water systems as families fill their pools, gardeners water their shrubs and lawns, and people wash their cars more frequently.

A reliable water supply helps ensure potable water reserves, adequate water pressure and fire protection.





#### **Environmental Sustainability**

Much of the water from sprinklers and hoses (such as from washing cars) runs off into the storm sewer, picking up pollutants that finally end up in our lakes and rivers. This is known as run-off pollution. Reducing outdoor water use reduces the pollutants that end up in surrounding bodies of fresh water.

#### **Responsible Infrastructure Management**

Water and wastewater treatment infrastructure are built to handle peak demand times, typically during the summer months, from 10 AM to 5 PM, when collectively we use the most treated water.

Reducing how much water we use during these peak times can reduce the need to expand pumping stations and treatment facilities - lowering construction and operating costs, and keeping the cost of proving water to your home and business lower.



#### **Watering Tips**

Early morning is considered the best time to water your lawn to avoid evaporation and grass diseases. Lawns only need about three cm of water weekly. A typical lawn sprinkler will deliver that amount in about one hour.

Rain barrels help protect the environment by reducing the amount of treated lake water used for watering gardens, and by diverting rainwater from the sanitary and storm sewer systems. They help conserve energy by reducing the amount of water and wastewater that Kirkland Lake needs to pump and treat, and save you money by lowering your monthly water consumption.

#### **BEARS & GARBAGE**



Residents are reminded that at this time of year there is a higher potential for black bear sightings in your neighbourhoods.

The Ministry of Natural Resources and Forestry (MNRF) cautions that at this time of year, natural food sources for bears can be scarce, so bears are seeking other available food sources (attractants), some of which may be available on or near your property. It is recommended that residents reduce attractants on or near residential properties by:

- Storing garbage properly and putting it at the curb for pick-up in the morning of collection day
- Do not miss collection day.
- Removing all bird feeders during foraging period.
- Do not place sweets or meats in outdoor composters.
- Freeze meat scraps until day of garbage pickup to help eliminate the smells.
- Clean BBQ after every use to eliminate food odors.

#### How, What, and Where to Bring?

#### HOW?

- For your own protection, deliver the labeled hazardous waste material in the trunk of your car.
- DO NOT mix materials.
- All materials must be clearly marked.
- If the container is damaged, package the container in a plastic bag in order not to spill it during the journey to the collection site.
- Wash hands thoroughly after handing the chemicals.

#### WHAT?

- Automotive and Garage Products (Antifreeze, transmission fluid, batteries and battery acid, gasoline, diesel fuel, kerosene, automotive fluids, motor oil, auto waxes)
- Paints and Paint Related Materials
   DO NOT mix latex with oil base paints
   (Oil base and latex paint,

- furniture and paint strippers, driveway sealers and roof patch, brus cleaners, primers, stains, varnishes, wood preserative, linseed oil, wood stains, varsol, solvents, thinners, and turpentine)
- Products
  (Flea collars and sprays, roach and ant poisons, arsenicals, fungicides, weed killers (herbicide), fertilizers, insecticides, molluscicides (slug & snail bait), rat and mouse poisons, mothballs)

Pesticides and Garden

- Household Cleaning Products
   (Ammonia-based, chlorine bleach, oven cleaners, disinfectants, drain decloggers (acids and bases), window cleaners)
- Miscellaneous Products
   (Aerosols (empty containers as well), nail polish & nail polish remover, dry cell batteries (disposable &

rechargeable), propane cylinders, BBQ lighter fluids, fluorescent light tubes and bulbs (unbroken), pharmaceuticals (medicines & old prescriptions) and sharps (place in a rigid plastic container), photographic chemicals, thermometers, thermostats and switches, glues and adhesives, pool chemicals and bleach (DO NOT MIX. Keep separate from each other and from other chemicals)

#### **NOT ACCEPTED**

- NO commercial, industrial or institutional wastes will be accepted.
- Radioactive materials, explosives, fireworks, ammunition, biological wastes, PCB wastes, helium or Freon tanks, or unknown waste.
- Old electronics and tires will not be accepted at this event.

#### **Ontario's transition to producer** responsibility

In 2021, the Ontario government released the Blue Box Regulation that shifts the financial and operational responsibility of recycling programs to producers - those that produce and supply blue box materials to residents. In this new extended producer responsibility framework, producers become financially and operationally responsible for collecting and recycling blue box materials.

#### Who we are

Circular Materials is a national not-for-profit organization that builds efficient and effective recycling systems where materials are collected, recycled and returned to producers to use as recycled content in new packaging and paper. As the administrator of Ontario's common collection system, Circular Materials is responsible for operating the new system for blue box materials. We are committed to increasing recycling rates across Ontario and ensuring more materials are looped into the circular economy, benefiting both people and the environment.

#### What does this transition mean for residents?

Transition to the new framework will occur in a phased approach over the next two and a half years. During this time, Ontarians will still be able to recycle the same materials as before.

#### Transition timeline

Transition to extended producer responsibility will take place between 2023 – 2025, with the new framework fully in place on January 1, 2026. Along with the Regulation, the government released a schedule that assigns each of the 376 Ontario communities a transition date.

#### Why the transition is important



- Historically, Ontario's blue box programs were operated by municipalities who shared the costs with producers. Now, under the Blue Box Regulation, Ontario is transitioning to a new model where producers are fully responsible for operating and funding the entire blue box program.
- In 2026, Ontario can expect a convenient, consistent, and effective recycling system in place that will improve recycling rates. This includes a consistent list of recyclable materials across the province.
- This new system operated by Circular Materials represents the evolution from product stewardship to a more circular economy where materials are collected, recycled and used again as recycled content in new packaging and products.

#### What does extended producer responsibility (EPR) mean?

EPR is a framework in which producers – the businesses that supply paper and packaging to residents – are responsible for managing the end-of-life management of these materials. EPR enables innovation, operational efficiencies, increased standard levels, and access to materials. It is recognized as one of the most effective mechanisms to improve recycling rates.
